☑ *Analysis of the existing good practices, tools and projects related to EHEA*

▪ Three focus groups:

- **governments** (5 May): representatives from 8 countries; Austria presented their national BFUG and other Bologna process related activities;
- **ENIC-NARICs, QA and promotion agencies** (11 September): representatives from 10 countries – 5 QAA, 2 QAA and ENIC-NARIC, 3 ENIC-NARIC
- **HEI and students** (22 September): NCR, HEI and students federations representatives from 10 countries – 4 students and 6 HEI together with EUA and ESU representatives members to the TF

Findings to feed into the recommendations.

Action plan

A1. Development of recommendations for BFUG members, including practical and hands-on guidance, destined to encourage active involvement of the academic community in the sharing of knowledge about the present and future goals of the EHEA and exploring collaborative ways to address them

Organising break-out sessions within the BFUG meetings to collect best practices and opinions from members and consultative members

- The BFUG Board decided to organise break-out sessions in **Madrid BFUG meeting** (16 – 17 November).
 - Plenary session of 30 minutes to set the context and present the background note and questions for discussions, as well as the purpose of the sessions;
 - 10 min break to move to the rooms;
 - 1 hour breakout discussion;
 - Plenary session of 30 minutes (the next day) to present the main outcomes and next steps (probably in the form of a panel).

Action plan



A2. Development of dissemination tools as videos and messages with EHEA visual identity, to be presented at the national/regional level and used for awareness-raising campaigns

- Topics to be developed:
 - **History of the Bologna Process,**
 - **Present:** fundamental values of HE, mobility, flexible learning, recognition, inclusion, quality and relevance (+ *the European Approach for the Evaluation of Joint Programs*), social dimension,
 - **Vision for future:** microcredentials, digitalisation, internationalisation,
 - **Why Bologna matters to you?:** addressing directly different stakeholders.

Action plan

A3. Series of TV/radio reportages /podcasts on topics related to the Bologna process

- **General layout for a podcast** (assemble and educate a team to generate online content)
 - Description, benefits, challenges and equipment for *Roundtable* and *Interview* type podcasts
 - **"Beyond Borders: Innovations in Higher Education"** podcast – description, structure, proposal of topics, plan for 3 episodes: *Qualifications Frameworks compatible with the QF-EHEA , ECTS, Lisbon Recognition Convention.*
- **Modular video script** (budget-friendly production of video content)
 - Examples, content recommendations, potential topics
 - "Building Bridges: Connecting Higher Education Communities" – feature video example (longer, high-quality videos that highlight interesting aspects of a topic. They can be used to educate viewers.)

A4. Development of guidelines for the BFUG members to organise events, at national, regional or international level, including ideas of topics and formats

- **General guidelines and ideas** for organising one or multiple events at the national, regional, and international levels: general description, event planning tasks list and budget planification.

A5. Developing the concept and organising sessions and side events during the BFUG meetings related to the dialogue about the Bologna process

- **April BFUG meeting in Brussels:**
 - capsules and video reportages looping on a screen,
 - table for distributing handouts,
 - and inviting attendees to engage by creating capsules on the spot or participating in interviews.
- **Ministerial Conference:** side events on the key commitments?
